

Trading Partner Testing for ICD-10

On April 1, 2014, Federal legislation was signed into law which delays the required adoption of ICD-10-CM/ PCS for at least one year. H.R. 4302, the “Protecting Access to Medicare Act of 2014”, states that the United States Department of Health and Human Services (HHS) cannot adopt the ICD-10 code set as the new standard until October 1, 2015.

Since the bill was signed into law, the Department has been re-evaluating our ICD-10 implementation plan. Although the ICD-10 code set will not be accepted prior to 10/1/2015, the Department has decided to move forward with EDI testing.

ODM will provide all active Trading Partners a window of time to test claims containing ICD-9 and ICD-10 code sets. The **CERT region is now available** in order to verify that the inbound and outbound transactions are being processed correctly (End to End testing). Additionally, ODM will be available to answer any questions you may have.

ICD-10:

All providers and payers under HIPAA are required to be compliant with ICD-10 on 10/1/15. Claims with discharge dates or dates of service prior to the compliance cutoff of 10/1/15, should continue to be coded with ICD-9 codes. Inpatient claims with discharge dates on or after 10/1/15 must be coded in ICD-10. Interim bills for long hospital stays are expected to follow the same rules as other claims. If an inpatient provider submits a replacement claim to cover all interim stays, the provider must re-code all diagnoses/procedures to ICD-10 since the replacement claim will have the discharge date post compliance. Outpatient and professional claims with dates of service on or after 10/1/15 must contain ICD-10 diagnosis codes. **Claims may not contain a combination of ICD-9 and ICD-10 codes.** Individual claims may only contain one code set. Outpatient and professional claims with from/through service dates that span the compliance date should be split into two claims (One claim for dates of service prior to 10/1/15, with ICD-9 codes and one claim for dates of service on or after 10/1/15, with ICD-10 codes).

Test scenarios:

Claim Type	Processing Requirement	Effective October 1, 2015
Inpatient and Inpatient Crossover	Providers are not allowed to mix ICD-9 and ICD-10 codes on the same claim.	Use THROUGH date
Outpatient and Outpatient crossover	For dates of service that span October 1, 2015, providers must separate claims submissions so that ICD-9 codes remain on one claim (dates of service before October 1, 2015) and all ICD-10 codes remain on the other claim (dates of service on or after October 1, 2015).	Use FROM date
Federally Qualified Health Center (FQHC)	FQHC crossover claims from Medicare are processed as outpatient crossover claims.	Use FROM date
Long-term care and Inpatient crossover	If the long-term care (LTC) claim has a THROUGH date on or after October 1, 2015, the entire claim is billed using ICD-10.	Use THROUGH date
Medical, Medical Crossover, and Dental	Use the FROM date on the detail.	Use FROM date on the detail

Important Information: UPDATED AS OF 05/26/15

- The CERT region will be adjusted so that the start date for accepting ICD-10 codes is 04/01/2015. Any claim submitted with a DOS or Through Date on or after 04/01/2015 must use the ICD-10 code set.
- PLEASE test all of your business scenarios, including dates of service prior to 04/01/2015 and after 04/01/2015.
- You will receive the 835 remittance advice for any providers who you currently receive the 835 remittance advice on behalf of in the production region.
- To enroll additional providers for the CERT region only, please send an email with the provider numbers and your Trading Partner number to DAS-EDI-Support@das.ohio.gov . Indicate in the email that this is for ICD-10 testing only.
- Previously paid claims are recommended.
- **For testing:**
 - Please set the ISA15 segment to “T” for testing
 - If you receive a rejected 999, please review the TRC file. Please make the corrections and send a new file through.
 - If there are any additional questions or concerns on files that receive a rejected 999 please contact DAS-EDI-Support@das.ohio.gov
 - Claim denials or claim payment related questions, please send an email to Mits_CGtesting@medicaid.ohio.gov
- Once the files are processed, please review the U277, 824, and 835 files.
