

MEDICAID ELIGIBILITY MANUAL TRANSMITTAL LETTER NO. 109

Subject: Medicaid: Transitional Medical Assistance Reduction

This MEMTL contains three new rules from Chapter 5160:1-4 and two amended rules from the same Chapter of the Administrative Code, adopted under section 111.15 of the Revised Code. The new rules replace one rescinded rule from Chapter 5160:1-4 and three rescinded rules from Chapter 5160:1-6. One of the rules was reviewed in accordance with section 119.032 of the Revised Code.

The effective date of the rules is January 1, 2016.

Chapter 5160:1-4 Medicaid for Families and Children

5160:1-4-01 MAGI-based medicaid: income and household income

This new rule replaces rule 5160:1-1-61 with no changes.

5160:1-4-02 MAGI-based medicaid: coverage for children younger than age nineteen

This rule is amended to change references to rule numbers and replaces the term “redetermination” with “renewal”.

5160:1-4-03 MAGI-based medicaid: coverage for Ribicoff and former foster care adults

This rule is amended to change a reference to a rule numbers.

5160:1-4-04 MAGI-based medicaid: coverage for pregnant women

This new rule replaces rule 5160:1-1-64 and changes references to rule numbers.

5160:1-4-05 MAGI-based medicaid: coverage for a parent or caretaker relative residing with a child

This new rule replaces rules 5160:1-4-05 and 5160:1-1-65 and changes transitional medical assistance (TMA) from 12-month initial eligibility to a 6-month initial eligibility with an

additional 6-month eligibility with quarterly income reporting as result of Am. Sub. H.B. 64, removes eligibility of TMA for minor children, removes language on continuous eligibility, changes references to rule numbers, and replaces the term “redetermination” with “renewal”.

5160:1-4-05 Medicaid: transitional medical assistance

This rule is rescinded and language is found in new rule 5160:1-4-05.

Chapter 5160:1-6 Non Medicaid Medical Assistance Programs

5160:1-1-61 MAGI-based medicaid: income and household income

This rule is rescinded and language is found in new rule 5160:1-4-01.

5160:1-1-64 MAGI-based medicaid: coverage for pregnant women

This rule is rescinded and language is found in new rule 5160:1-4-04.

5160:1-1-65 MAGI-based medicaid: coverage for a parent or caretaker relative residing with a child

This rule is rescinded and language is found in new rule 5160:1-4-05.
