Overall Care Management Rate: Intensive Risk Level (Engaged and Passive Participation Care Management Status)

The intensive risk level care management rate for members during the reporting periods specified below.

Numerator: Sum of the numerators used to calculate the monthly intensive risk level care management rate during the measurement period.

Denominator: Sum of the denominators used to calculate the monthly intensive risk level care management rate during the measurement period.

Monthly Intensive Risk Level Care Management Rate:

Numerator: The number of members assigned to the intensive risk care management stratification level, who were also classified as having an engaged or passive care management status, on the first day of the reporting month.

Denominator: The total number of members enrolled in the MCP on the first day of the reporting month.

***Exclusions:** Given these measurement periods fall outside the January – June 2017 transition period, members who are assigned a Comprehensive Primary Care (CPC) status are not eligible for inclusion in the numerator or denominator of this measure.

Denominator: Sum of the denominators used to calculate the monthly intensive risk stratification level engaged care management status rate during the measurement period.

Monthly Intensive Risk Stratification Level Engaged Care Management Status Rate:

Numerator: The number of members who were assigned to the intensive risk care management stratification level, and who were also classified as having an engaged care management status, on the first day of the reporting month.

Denominator: The total number of members enrolled in the MCP on the first day of the reporting month.

***Exclusions:** Given these measurement periods fall outside the January – June 2017 transition period, members who are assigned a Comprehensive Primary Care (CPC) status are not eligible for inclusion in the numerator or denominator of this measure.
